## Scope

This privacy policy will explain how our organisation, Emmerson Wills Limited, uses the personal data we collect from you when you use our website.

## What data do we collect?

Our Company collects the following data:

• Personal identification information (Name, email address, phone number, etc.)

## How do we collect your data?

Said documents are stored in secure cloud-based file stores.

Our Company will keep your personal data for 12 months with no engagement and 24 months following termination of engagement. Once this time period has expired, we will delete your data by placing in the digitised recycle bin and then emptying the recycle bin. Print format shall be suitability shredded.
